This has reference to the proposal submitted by Prestige Institute of Management and Research, 2, Education and Health Sector, Scheme No. 54, Indore-452 010 Madhya Pradesh affiliated to Devi Ahilya Vishwavidyalaya, Indore for extension of autonomous status under the UGC Scheme for Autonomous Colleges.

On the basis of the report of the UGC Expert Committee, the Standing Committee in its meeting held on 02.11.2018 decided to grant extension of autonomous status to Prestige Institute of Management and Research, 2, Education and Health Sector, Scheme No. 54, Indore-452 010 Madhya Pradesh affiliated to Devi Ahilya Vishwavidyalaya, Indore for a period of five years w.e.f. 2018-2019 to 2022-2023.

Further, it may be noted that the above said college shall also apply in the prescribed format to University Grants Commission for extension of autonomous status six months prior to the expiry of the autonomous cycle.
