




PROGRAMS

B.A., LL.B.(Hons.)

The course shall open avenues to the pursuant in the areas of litigation, judiciary, Indian Defense Services (J.A.G.), judicial clerkship, legal officers in private and public sector enterprises. The course in specific shall give the pursuant an opportunity to explore possibilities in building career in the areas of active consultancies to social and political organizations pursuing PSC (Central and States).

B.B.A., LL.B.(Hons.)

Admission in the course shall open avenues to the pursuant in the areas of litigation judiciary, Indian Defense Services (J.A.G.), judicial clerkship, legal officers in private and public sector enterprises. The course shall specifically give an edge to the pursuant in endeavoring opportunities in the area of departmental compliances of Multi-National Companies, corporate liaioning and public relations.

LL.B.(Hons.)

The pursuant shall have the opportunity to choose between specialization in 'Business Law', 'International Law & Organizations' and 'Criminal Law'. Other than the aforementioned possibilities a LL.M. student can pursue his career in the areas of Academia and Social & legal research.
